Success Stories	SHISUK supported 127 migrant workers in obtaining compensation. In 1999, 127 Bangladeshi Migrant Workers (MWs) were legally employed by two Malaysian companies: Chung Wah Plastic Co. and Fiman Packaging Co. However, the Malaysian employer failed to pay their wages regularly as per the contract. When the workers demanded their salary, overtime, increment, etc., the employer mentally and physically tortured them, forcefully throwing out some MWs and damaging their passports and other legal documents. This incident highlights a violation of the UN Convention of 1990 regarding MWs' rights.
	The employer unlawfully managed 79 MWs, while the remaining 46 MWs were determined to strive hard to establish their legitimate rights. Those 46 migrant workers received Tk 1.3 million, equivalent to RM 839,936. After a 7-year legal battle against their employer, the rights of the deprived Bangladeshi Migrant Workers were finally established. The Malaysian High Court gave the verdict on April 18, 2005, upholding the judgment of the Malaysian Labour Court delivered on April 24, 2000.
	Unfortunately, the survivors were unable to unite themselves to raise their voices against the traffickers and the flagrant violation of their rights. Since 1997, SHISUK has been working to organize self-help groups and Community-Based Organizations (CBOs) of migrant workers.

SHISUK has been implementing the Survivor Support Service supported by the WI ACT program since 2009 and has supported 268 survivors to date.

SHISUK has fulfilled its targeted responsibilities, and the project has achieved significant milestones in the areas of rescue, prosecution, and reintegration. SHISUK was closely involved in the total process of rescuing and repatriating 19 survivors from a Tanzanian jail. The survivors were repatriated from the Tanzanian jail on September 21, 2012, after 9 to 21 months of struggle. The news received priority coverage in electronic and print media. SHISUK continues to support the survivors in the processes of prosecution and repatriation.

In terms of prosecution, the ACT-SS program implemented by SHISUK has facilitated the filing of the first case of a male trafficked victim under Manob Pachar Protirodh O Domon Ain 2012 at Noagoan Judge District Court. Additionally, four other cases were filed on behalf of survivors in Manikgonj, Kapasia (Gazipur), Meherpur, and Rajshahi.

SHISUK-ACT-SS program was also involved in the process of rescuing and repatriating, prosecuting, and integrating 19 survivors from Nepal. The program provides legal support to survivors for their cases under Manob Pachar Protirodh O Domon Ain 2012. After receiving lifeskill and entrepreneurship training, 12 survivors among these 19 initiated an excellent collective enterprise in Meherpur district for livelihood reintegration, with necessary support from SHISUK.
