Success Stories	During the pandemic, a seafarer seeks assistance from ACHIEVE. Upon receiving his Pre employment medical exam (PEME) result, it was found out that he is HIV+. The diagnostic clinic gave him a certification of unfit to work. The agency then decided that he would not be able to work as a seafarer again. ACHIEVE, through a help of lawyer, had several dialogues with the recruitment agency. ACHIEVE used RA 11166 or the National HIV and AIDS Policy Act as legal basis for the seafarers right to be employed. Since the seafarer is not going to any country with HIV travel ban, there is no reason for the agency to deny him employment. After three dialogues, the client was allowed to board as a seafarer. The client finished two more contracts after this event.
